

**eCampus.com Home for the Holidays Sweepstakes
Official Rules
November 21, 2011 – December 20, 2011**

PRELIMINARY INFORMATION: NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. The eCampus.com Home for the Holidays Sweepstakes (“Sweepstakes”) is subject to all applicable federal, state and local laws. Odds of winning depend on the total number of eligible Entries (defined below) received.

SPONSOR: The Sweepstakes is sponsored by A Book Company, LLC., located at 2373 Palumbo Drive, Lexington, Kentucky 40509 (“Sponsor”).

SWEEPSTAKES PERIOD: The Sweepstakes begins at 9:00 am ET on November 21, 2011 and ends at 11:59 pm ET on December 20, 2011 (the “Sweepstakes Period”). You may enter online by visiting the Website (defined below) at anytime during the Sweepstakes Period. You may also enter through a third party application located on the Facebook Page (defined below) between 12:01 am ET on November 21, 2011 and 11:59 pm ET on December 20, 2011. All times in the Sweepstakes refer to Eastern Time (“ET”).

ELIGIBILITY: Open only to permanent, legal United States (“U.S.”) residents physically residing in one (1) of the fifty (50) U.S. or the District of Columbia (excluding Puerto Rico, Guam, U.S. Virgin Islands and all other U.S. territories) who are eighteen (18) years of age or older and have reached the age of majority in their state of residence at the start of the Sweepstakes Period. Entrants must have a valid U.S. Social Security Number or a valid U.S. personal tax identification number. Once you “like” the Facebook Page, follow the provided instructions to complete and thereafter submit the Entry form, which includes your name, email address, and date of birth (“Facebook Entry”, collectively with Website Entries, will be referred to herein as “Entries”).

Limit one (1) Entry per day per person/email address during the Sweepstakes Period, regardless of method of entry. All Entries become property of Sponsor, and will not be acknowledged. **Entries must be received by December 20, 2011 at 11:59 pm ET to be eligible for the Sweepstakes.** Sponsor’s computer shall be the official timekeeper for all matters related to this Sweepstakes. Entries generated by a script, macro, or other automated means will be disqualified. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
